I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin hereby release and hold harmless Lazer Tag Party LLC, their officers, officials, agents and or employees, from any and all liability for injury, disability and loss or damage to personal property. I freely assume all such risks both known and unknown and assume full responsibility for my participation. I have read and understand the rules and agree to fully comply with all regulations during my participation. If the party is held on a property owned by some person or organization other than the participant's, it is understood that the event is in no way sponsored by the property owner and the property owner or their representatives assume no responsibility for the conduct of or safety of the event/activity. The participants shall hold harmless the property owner from any cause of action, claim, and petition arising from the use of the property related to laser tag..

1. START: All customers agree, as a contract, to the releases, indemnities or waivers to Street Games. These conditions for participation were available for you to read at the time of completing this form. Further, this Certificate and these "conditions for participation in Laser Tag riding, releases, waivers and indemnities" provides you with a written record of your agreement that you may keep.
2. Minors: Customers that are under 18 years of age ("the Minor") provide the release, indemnities and waivers to Street Games through the parents or guardians or adults acting as a party authorized by the parent or guardian of the minor ("the representing guardian") that has completed this form. This form is however designed to address the information needs of minors as far as they can understand the nature of the activity and to that extent their consent will be evidence of their own separate agreement as the Customer.
3. Releases: The Customer agrees as part of being provided with access to the Laser Tag Equipment and being trained and use of the Laser Tag Equipment releases and forever discharges Lazer Tag Party, LLC and their officers, directors, members, employees, and agents, and each of them; the owners of any real property or other facility which may be utilized in this activity; any manufacturer of any equipment or devices used in connection with my use of the laser tag equipment (the "released parties"), from all losses and damages (including any losses caused by the acts or omissions of the named released parties) all claims, suits, payments and judgments, including attorney's fees, arising from any and all of my personal injuries, harm, fright (including death) which may arise from my use of the laser tag equipment, whether or not such injuries are the result of ordinary or gross negligence.

The customer further releases the release parties against any use of the information collected from the Customer including all Customer data and images or recordings for all lawful uses. Lawful uses shall include use of survey comments, guest book entries and recorded images for publicity purposes. 4. No product liability: No manufacturer related to provision of the facility or equipment used as part of the lazer tag system guarantees that equipment will not fail.

5. Indemnities: The customer and the representing guardian (where applicable) indemnifies the released parties against all and any claims made by any party due to their relationship to the Customer and/or the representing guardian and their accepting these conditions for participation or otherwise arising from any representation, act or omission while using the Street Games facilities. 6. Health: The Customer, in completing this form has represented that the Customer is in good physical and mental health and is otherwise on the physical condition to participate in laser tag activities.

7. Burden of Proof: The Customer is providing the releases of liability and waivers and indemnities for all phases of my use of the laser tag equipment and related equipment, and agrees that this document be broadly construed in favor of any and all of the released parties to the effect that any and all ambiguities be resolved in favor of any and all released parties.

8. Governing Law & Jurisdiction: it is further agreed between the parties that no matter where venue lies, any lawsuits shall only be filed in Georgia and, if filed in any other Court or County be moved to the Courts Forsyth County on the motion of and at the option of any of the released parties.

9. Contract status: by continuing to participate after completing this form and having had the opportunity to read this and withdraw with a full refund at any time, you, the Customer (and the representing guardian where applicable) are entering into a legally binding contract. If any court should decide that any clause of this contract is illegal or unenforceable, such determination shall not affect the validity and enforceability of the remaining provisions hereof, all of which shall remain in full force and effect.
